Manager Anderson introduced Chief Butler who gave an update on the Peace Officers memorial, May 15, 2015.

Jeff Barsh gave an update to both Councils regarding the 2014-2016 MDOT Bridge Project. -Winter work included cables, chains, mechanical upgrades, electrical and lift motors. -April 15-December 15 Concrete steel rehab, deck repairs, spot painting, led lights, cameras, warning gates and barriers Expect one lane closures in each direction. June-15 to December 15 Expect single lane closures September 15 –December 15 Expect one side lane closures and running two-way traffic. Open for Boats on demand Winter 15-16 Electrical rehab and final testing and balancing. Spring 2016 – Completed

Marilyn Clark CEO, SmartZone Gave a brief history of the Hancock/Houghton SmartZone Marquette Satellite update. Will have to extend the Hancock/Houghton SmartZone to 2033.
